

TE AWAMUTU PRIMARY SCHOOL (2002) ENROLMENT SCHEME 2015

Enrolment Scheme Written Description

Start at the intersection of Kihikihi Road (SH3), Golf Road and St Leger Road.

All addresses on St Leger Road, up to and including 125 and 132, are included in the zone. All of Lawbrooke Lane and Leger Grove are included within the boundary.

From 132 St Leger Road, the boundary runs across country to the intersection of Pokuru Road and Budden Road. Addresses on both sides of Pokuru Road, east of Budden Road (up to and including 323 and 320 Pokuru Road) are within the boundary.

The boundary then runs along Budden Road and Ray Road including addresses on both sides of the two roads. From the end of Ray Road, the boundary continues northwest across country to include all of Papesch Road.

From the northern end of Papesch Road, the boundary follows along Hawthorne Road, Mangapiko School Road, and Bowman Road, and includes all addresses on these roads.

At the intersection of Bowman and Paterangi Roads, the boundary turns south down Paterangi Road (including all addresses up to and including 890 and 909) and then tracks along Bank Road.

From the end of Bank Road, the boundary runs east to the intersection of Te Awamutu Road (SH3) and Jary Road and includes addresses south of that intersection, 4652 and 4685 Te Awamutu Road and above.

All of Thompson Road is included and, from the east end of Thompson Road, the boundary encompasses all of Sutton Road and addresses on Te Rahu Road including, and west of, 2069 and 2108.

The boundary then continues south down State Highway 3, including all addresses on Ohaupo Road (SH3) north of Benson Road, as well as addresses on the northern side of Benson Road (odd numbers) up to and including 203.

South of Benson Road, only the western side of Ohaupo Road (SH3) is within the boundary. It then follows on to Albert Park Drive (SH3) and turns right into Park Road, including all addresses on these roads, as well as all of Domain Road.

From the south end of Park Road, the boundary turns west into Golf Road, and includes all addresses west of the Park Road intersection, to arrive at the starting point of the intersection of Kihikihi Road (SH3), Golf Road and St Leger Road.

All students living within the boundary of the home zone, as described above and shown in Figure 1, are entitled to enrol at Te Awamutu Primary School.

Each year, applications for enrolment in the following year from in-zone students will be sought by a date which will be published in a daily or community newspaper circulating in the area served by the school. This will enable the board to assess the number of places which can be made available to students who live outside the home zone.



Out of Zone Enrolments

Each year the board will determine the number of places which are likely to be available in the following year for the enrolment of students who live outside the home zone. The board will publish this information by notice in a daily or community newspaper circulating in the area served by the school. The notice will indicate how applications are to be made and will specify a date by which all applications must be received.

Applications for enrolment will be processed in the following order of priority:

- First Priority must be given to any applicant who is accepted for enrolment in the following special programme(s) run by the school and approved by the Secretary for Education.
- Second Priority must be given to any applicant who is the sibling of a current student of the school.
- Third Priority must be given to any student who is the sibling of a former student of the school.
- Fourth Priority must be given to any applicant who is a child of a former student of the school.
- Fifth Priority must be given to any applicant who is either a child of an employee of the board of the school, or a child of a member of the board of the school.
- Sixth Priority must be given to all other applicants.

If there are more applicants in the second, third, fourth, fifth or sixth priority groups than there are places available, selection within the priority group must be by ballot conducted in accordance with instructions issued by the Secretary under Section 11G(1) of the Education Act 1989. Parents will be informed of the date of any ballot by notice in a daily or community newspaper circulating in the area served by the school.

Applicants seeking second or third priority status may be required to give proof of a sibling relationship.
